
# Report Summary

- Report is distributed from VP Finance Office (typically) on a monthly basis

- There are eleven tabs contained in the Excel Workbook, which is generated from Cognos.
- Where appropriate you will find comments at the bottom of each tab contained in the reports
- The first tab, titled **CHART 1**, shows projections for the current Fiscal Year.


# Sponsored Primary Program Expenditures with Projected Data for Current Fiscal Year




